
## **Procedures for Tender Offer Acceptance and Subscription for NVDR**



- 4. Enclose the following supporting documents with certified as true copy, as the case may be:
  - 1) Thai Individual
    - A certified copy of a valid ID Card that has not expired or
    - A certified copy of a valid Civil Servant ID Card or a copy of a valid State Enterprise Employee Card that contains 13-digit ID numbers that has not
      expired

If the Offeree is a minor child, the Offeree must attach a consent of his/her guardian (father and mother), a certified true copy of his/her guardian's Identification Card, a certified true copy of the guardian's and the minor child's the house registration

In case of name, title, or surname discrepancy between that appears on the securities certificate and that appears on the Identification Card, the Civil Servant Identification Card or the State Enterprise Employee Card, the Offeree has to fill in the "Request Form for Rectifying Items in the Securities Holder Record" of TSD to be submitted with a copy of evidence of such correction issued by the government authority, certified as true copy. The new information must conform to the Identification Card, the Civil Servant Identification Card or the State Enterprise Employee Card.

- Foreign Individual
  - A certified copy of a valid passport or a copy of a valid alien certificate that has not expired
- 3) Thai Juristic Person
  - 3.1) A copy of a juristic entity's affidavit, issued by the Ministry of Commerce no longer than 6 months prior to the submission date, certified as true copy by authorized signatory(ies), and affixed with company seal (if any) and
  - 3.2) A copy of documents specified in 1) or 2) (as the case may be) of the authorized signatory(ies) who sign(s) and certify(ies) true copy of document in 3.1) above
- 4) Foreign Juristic Person
  - 4.1) A copy of a Certificate of Incorporation (the juristic entity's affidavit) issued by the officer of the juristic person or the government authority of the country in which the juristic person is established, certifying the name of the juristic person, the name of authorized signatory, the location of the head office and conditions of signing authorization (issued not exceeding 1 year prior to the submission date) certified as true copy by the authorized directors of the juristic person together with the company seal
  - 4.2) Documents stated in 1) or 2) of the authorized director(s) who sign(s) and certify(s) true copy of document in 4.1) above

Documents specified in 4.1) and 4.2) must be certified by the Notary Public and Royal Thai embassy or Royal Thai consulate in the country where the documents were prepared no longer than 1 year prior to the submission date

Remark: As the identification documents of the Offeree e.g., copy of identification card, may contain sensitive personal data such as blood type, race, religion, etc. which is not necessary for the provision of the tender offer acceptance and the Tender Offer Agent has no intention to collect such sensitive personal data. Therefore, before submitting the identification documents to the Tender Offer Agent, the Offeree is requested to cross out or conceal your sensitive personal data in your identification document and notify the transferee to also cross out or conceal the sensitive personal data in his/her identification document. In case where the Offeree and/or the transferee submit the identification document without concealing any sensitive personal data, it shall be deemed that the Offeree and/or the transferee agree to the Tender Offer Agent to cross out or conceal the sensitive personal data and that such concealed identification documents are considered valid and legally enforceable in all respects.


